

#### **USAT Certified Seminar**

#### Costs:

- Certification seminar fee \$70 (can register online or pay at the door by Cash, Cashiers Check/Money Order (made out to MSTA)).

  - Audit fee \$40 (can register at the door (Cash, Cashiers Check, or Money Order made out to MSTA).
  - Any age, any belt can participate as an auditor. \*\*\* Auditor will not be tested or receive certification \*\*\*

#### Time:

Poomsae seminar will start at 9am and expected to finish before 6pm (depending on the amount of participants).

#### Course:

Level 1

#### Participant:

- is required to be 15 years old or up
- is required to be USAT member.

- can be Red belt or 1<sup>st</sup> Dan/Poom black belt or up
  - Red belt can participate in the seminar and get "P" class.
    - Once he/she receives their black belt they will then be promoted to Level 1.
- is required to score 70 and above to pass.
- is required to know up to Taebaek Poomsae.

#### Test:

- Written test -50% (all the answers will be reviewed during the seminar).
- Scoring test-40% (participant is required to score two Poomsaes).
- Practical test-10% (participant is required to perform 1-2 Poomsaes, one from Taegeuk 4-8, one from Koryo, Keumgang, or Taebaek).

#### Level 2

#### Participant:

- is required to hold USAT Level 1 Poomsae referee certification
  - o There is no time restriction between Level 1 and Level 2 at this moment.
- is required to score 80 and above to pass
- is required to know up to Shipjin.

#### Test:

- Written test -50% (all the answers will be reviewed during the seminar).
- Scoring test-40% (participant is required to score two Poomsaes).
- Practical test-10% (participant is required to perform 1-2 Poomsaes Pyongwon and/or Shipjin).
